# President's Annual Report

The past year for Dogs New Zealand (Dogs NZ) was very successful, our events that are covered more fully below were all excellent and of a very high standard. Our principle sponsor Black Hawk continues to work with us as a valued partner and the benefit that Dogs NZ derives from the relationship cannot be overstated.



This year we had a change in Director/Secretary with the resignation of Peter Dunne. I extended gratitude to Peter who managed Dogs NZ professionally over his period in office. His strength was building relationships with outside organisations in promoting Dogs NZ. The other strength is on balance he left Dogs NZ in a stronger financial position.

This led us to welcome Steven Thompson our current Director/Secretary, Steven has a marketing background and this together with his experience in governance with non-profit entities will be of value as Dogs NZ seeks to grow the membership.

The resignation of Beth Warman from the Executive Council this year led to the elevation of Brian Harris back on to the Executive Council. I thank Brian for stepping up and his experience around the table is welcomed.

The following people come to mind to thank for their efforts over the last year. Geoff Collins and Paul Robinson for the time and commitment to the appointment process of the Director/Secretary. Lisa Slade and Karen McIntyre for all the behind the scene work at the Black Hawk National Dog Show 2018, while Keith Brown and I were visible to all. Steve Tate for chairing the Canine Health and Welfare Committee and Show Manager for the Black Hawk National Dog Show 2018, Keith Brown for his work with the Museum Trust and taking the lead for the 2019 Black Hawk National Dog Show, Geoff Collins as Senior Vice-Chair and Chair of our Obedience Committee and Bevan Dale for his work on the Agility Committee. Anne Coulson our independent Chair of Audit and Finance Anne Coulson and the numerous people whom have assisted with our national events over the 2018 year.

## Financial

The Financial performance for the year ended 31 March 2019 saw a result of \$57k surplus after depreciation while revenue increased 3.6% or \$66,384 (this was mainly driven by price increases). We still have work to do to increase the membership and the value people see in belonging to Dogs NZ.



On the other side of the ledger the costs were down 8% or \$152,264. This was driven from staff vacancies, subcommittee expenses, Black Hawk National Dog Show (using own venue) and other expenses.

The budget for 2020 has risk with a growth in revenue (against the trend) and continuing cost increases. This will make for a challenging year once again, however restraint will be applied to the cost structures.

# Committee Reports

## Agility

The recent year was nothing if not busy. Thanks to the previous Agility Committee, there were some great initiatives undertaken. One of the highlights was the Global Judging Program training which was a huge success with 40 of 51 Judges attending. The skills learnt, and discussions held will certainly make for some positive changes amongst our judges I am sure.

After an exhaustive process, the jump heights were amended with the new 5 height system coming into the force in January. This type of change is never easy, but I am sure that the effort the previous committee went to in this regard was appreciated by everyone.

The NZDAC was held in Feilding over Labour Weekend and was formally livestreamed for the first time for all rings. There were several new innovations on show including instant results screens being utilised. Every year the NZDAC seems to take a step forward and it is exciting to see committees trying new things and working to improve the way we do things in our sport.

The annual Junior Dog Training camp in January was a huge success thanks in no small part to the amazing work done by volunteers who make it the highlight of the year for so many of our up and coming handlers. (Full report elsewhere)

This year we have agility at the National Dog show in Blenheim followed by the NZDAC in Cromwell. Both promise to be something to look forward to. Cromwell is shaping up to be a popular destination and the event is coming together really well with lots of great ideas and hard work on the part of the Zone 5 organising committee.

The new Committee is making efforts to engage with clubs and competitors face to face as often as possible and is keen to keep this up. Clubs will be a major focus for the remainder of 2019 and we aim to help the agility clubs remain strong and assist them where they need help. Without our clubs we have no shows.

April saw the kick off for discussions around the Agility Strategy for the next 5-10 years commencing with getting an understanding of what people like and don't like about the sport and where they see it in 2030. Getting an understanding of the answers to these questions is a first step toward coming up with a plan which everyone in agility can relate to and buy into. Hopefully once complete it will drive the direction of the Agility Committee and will be the basis for decisions made going forward. 🐾

## Breed Standards

The Breed Standards Committee met three times during the year via teleconference and conducted several matters via email.

The retention of the weighing of Miniature Dachshunds was approved by the Executive Council following careful consideration of the many submissions received. It is noted that the Chairperson of the Breed Standards Committee took no part in those discussions.

We reviewed several items referred to us by Executive Council and submissions received from clubs and individuals. These related to:

- Portuguese Water Dog
- French Bulldog
- Bulldog

No changes were made to any of the Standards however an amended preamble to all Breed Standards was recommended by the Canine Health and Welfare Committee and endorsed by the Breed Standards Committee and subsequently Executive Council. These changes include the words "Breeders and judges should at all times be careful to avoid obvious conditions and exaggerations as well as being mindful of features which could be detrimental in any way to the health, welfare or soundness of this breed."

During the year we were advised of an amendment to The Kennel Club (UK) Standards, which are also used in New Zealand. This related to the Schipperke and the changes were adopted

Finally, I take this opportunity to thank the members of this committee for their work and contribution during the year: Annette Buxton, Wendy Schwalger, Kathleen Hardwick and our Executive member Beth Warman who was replaced by Brian Harris after Beth's resignation from Executive Council. 🐾

## Canine Health & Welfare

2018-2019 has been another year of increasing pressure on those involved with animals. We are experiencing a society of expanding awareness and sensitivity around the use of animals, from those at our side to those on our farms. To best cope with the changing goalposts of social licence, the Dogs NZ Canine Health & Welfare Committee (CHWC) work tirelessly for the Dogs NZ membership, and most importantly our dogs.

Dogs NZ will be presenting to the National Animal Welfare Advisory Committee (NAWAC) in May 2019. This presentation will demonstrate steps that we have taken to address NAWAC's concerns about animal welfare associated with selective breeding as published in their Opinion in March 2018. The Opinion has been the document from which both the CHWC and Dogs NZ Brachycephalic Working Group (BWG) has set its objectives, so we are well prepared to represent the membership to this highly influential group.

The Breeders Code of Ethics (BCOE) has been renamed the Breeders Code of Conduct (BCOC) to better reflect that it is a mandatory set of rules which we expect members to abide by for the good of our dogs and the organisation's reputation. It has seen a major overhaul where changes were made to better provide for the difficult balance of maintaining the best level of animal welfare possible, while keeping our gene pool as large as possible. It was recognised that for some specific points in the BCOC there is overall benefit to keeping progeny from BCOC breach breedings on the pedigree registers, with a balance struck to strongly discourage breeders from breaching the Code by implementing fines and disqualifications.

The Labrador Clubs Litter Registration Limitation (LRL) has now been in place for almost two years. This commendable achievement by the breed clubs to self-impose mandatory health testing on parents prior to registration of progeny has already achieved significant gains for the health of the breed. It has meant that in one generation clinical effects of three different DNA conditions have been eliminated. Hip and elbow dysplasia scores and eye certificates are received and stored against the dog's pedigree record so that trends can be monitored, and average scores can be calculated across the many different testing schemes that are used. In 2019 this statistical information will be sent to the Labrador Clubs so that they can get a picture of the current health scores in New Zealand.

The Rottweiler Clubs have recently been through the same process and seen over 80% participant support for every proposed LRL, with hip and elbow dysplasia testing getting 100% support. The Rottweiler LRL will be in place from the 1st of August 2019 and the CHWC look forward to being able to proudly present to external stakeholders that because of

our breeders and the good work they do, from 1st August 2019 there will be no Dogs NZ Pedigree Rottweiler puppies born affected by the fatal disease juvenile laryngeal paralysis and polyneuropathy (JLPP) as just one of 6 mandatory health tests for the breed.

The LRLs are embedded in the Registration Regulations and sanctioned by setting the specific requirements of the LRL in the Registry. LRLs act to improve the health and welfare of the breed and provide an extremely valuable position to present to external regulatory and welfare group bodies. CHWC has been approached by 3 other breed Clubs who would like to move down this path, for which we are happy to help.

Significant upgrades have occurred in the registry system and website interface so that health test result files can be uploaded by a Dogs NZ member and then checked and entered by a dedicated Dogs NZ staff member. The result is stored on the dog's pedigree records and able to be printed on the pedigree certificate of its progeny. The storage of health data beyond the Accredited Breeders Scheme (ABS) and the ability for health results to be printed on pedigree certificates has been a major goal for Canine Health & Welfare and we cannot thank Mark Signal and Sue Conner enough for their work in achieving it.

2019-2020 will present Dogs NZ with ongoing challenges in the animal welfare domain as we are increasingly found needing to defend and justify the activities of our membership. This will continue to be done with strong support from the CHWC, and a relentless demand for reference to scientific reason. Each Dogs NZ member has their own role to play in the continued success of the pedigree dog and our sports and activities by being the best owner, breeder, handler, competitor that they can be, and always making animal welfare a priority.

My most heartfelt thanks to the Canine Health & Welfare Committee, who give their time freely for the pursuit of canine health and welfare.

There is no recognised title for it, but it leads into the CGC programme.

## Obedience

Dog Obedience, like some other areas of Dogs New Zealand, is facing challenging times with a slow decline in show entry numbers. There does not appear to be an easy fix to this as there is not one single cause. However we have been considering ways in which we can address this problem. Some adjustments to the conduct and requirements of the obedience tests at shows will be part of this to try to help retain existing competitors but that is unlikely to make a huge difference to how we attract new competitors or retain those who are just starting out.

Part of the solution is really in the hands of the obedience community who need to ensure that the environment at obedience shows is welcoming and friendly so that all people feel comfortable taking part, whether they are what might be considered serious competitors or whether they are just happy to give it a go and enjoy the social aspect of shows. To attract new people and to give existing members additional choices we are also aiming to introduce some new activities including scent work trials where a dog tries to locate and indicate a scent hidden in a defined area such as an outside ring, inside a building or in a vehicle.

This year we will have held the second National Dog Obedience Assembly (NDOA) at Easter after we moved this from Labour Weekend as part of a three-year trial. This was an initiative by Executive Council to separate the three Dogs NZ National events (National Dog Show, NZ Dog Agility Championships and the National Dog Obedience Assembly) so that they don't all fall in October. This has been quite challenging and there have been calls from the Obedience community to bring forward the vote on whether we should move back to Labour Weekend after the trial. This vote was still running at the time of writing this report so the result is unknown but there is the possibility that the NDOA will move back to Labour Weekend starting in 2021.

In July we will be holding our second Domestic Dog Training Conference in Wellington. We are hoping most of our clubs that run domestic dog training classes will be able to send a representative. We will also be presenting our second Domestic Dog Training Club of the Year award at the conference. One thing we still hope to develop, something that came out of the first conference in 2017, is a dog training certification scheme and we have been working with the New Zealand Companion Animal Council on a scheme that they intend to introduce quite soon.

I am standing down as Dog Obedience Chairperson and Executive Councillor this year after six years in the position. I would like to wish the new Obedience Chairperson, Arend van den Bos, all the best for the future and to thank the other members of the Dog Obedience Committee for



all their work over the past years. I would also like to thank the members of the Executive Council for their support over the last six years as well as the many Dogs NZ members who have been supportive and encouraging during my time on the Council. 🐾

## Auckland Property Management

On the 30th January an Open Member Meeting was held at the Auckland grounds. The purpose of the meeting was to give members an update on what's happening at the venue in relation to the Auckland Unitary Plan and where we are with all of our site consents. We would thank everyone who attended and we are currently looking at turning this into an annual event.



In the Auckland Unitary Plan (AUP), the site at 743 Papakura-Clevedon Road Ardmore and the surrounds are zoned Mixed Rural. What this means for us is until 2050 – No further subdivision under 40ha, will be allowed in our area. Which means if the membership decided to sell there would be a smaller buyer pool and Ardmore airport will also dictate who our neighbours will be, also who may purchase our property. The AEC committee has recommended that the current Auckland Venue is well suited to the needs of our members, but as a venue we do need to expand on revenue opportunities.

In regards to our consents;

- Storm water consents have further lifespan of 20 years.
- The front paddock can be used for canine use and racing once the tress are over 2mtrs in height.
- All other activitys consents do not expire for canine purposes. The extra thing that we have is that the building can be used for film shoots.
- Parking over approved areas and a restricted number of weekends per year. Current rules require self-containment.
- Waste water consents expired in 2015. A renewal process was apprised, and the system was deemed to be outdated and Council would only issue a covering consent for five years. We have used a temporary solution to this and the waste water is now stored in a large tank. A new waste water system needs to be built and integrated into the improvements that we have made. This new system would future proof the system for the next 30 years - \$30k. This is deemed an urgent project.

The Auckland grounds are set up and consented for canine events and related activities. We also have a consent to hold film shoots on the grounds as well. There is an option to revisit our consent process through



Auckland Council and get our approved activities expanded. The estimated cost to do this is 25K. The Auckland committee is very keen to work with a marketing expert who may be able to get us out to the right sort of new customers so that we can expand on our revenue opportunities.

In general news we continue with annual maintenance and groundwork projects. Our great Benefit Shows certainly help fund these projects. They are always well supported and a good profit from these shows goes towards our larger maintenance projects – like the current one of redoing all of the guttering in the toilet block. Thank you all for your great support for these events.

I would like to take a moment to thank our contractors and our dedicated team of volunteers and committee members for all of their hard work during this last year. It is a big ask to get people to give up their time before, during and after shows to help us do what we need to do to provide the best show experience for everyone else and a great venue for us all to use. 🐾

## Forrester Park Management

Building maintenance continues to be the major focus for Forrester Park with some of the essential structural work having been completed. There is still essential fire egress work to be completed, however with funds now having been approved, the committee can move forward with this project. A quote has been accepted for maintenance to the front entry to be carried out that will also address the fire egress requirements.



The floodlights are beginning to fail so we are in the process of costing and replacing them with LED lighting and we are working through whether to replace the existing sodium lights as they fail or to replace them all at once. The outcome will depend on the cost and budgeting constraints.

Steven Thompson has been working with the DCC on our overdue 20 year lease and is close to signing it off. This will take the lease to 2037. We look forward to it being signed and thank Steven for progressing it.

The DCC has initiated a series of meetings between themselves, FPMC & Dogs NZ clubs to discuss ways forward so that the use of the park is more acceptable for both the public and the groups that use it for events. One proposal, that had been turned down in the past by DCC, is to subdivide an area off so that the public always have somewhere to run their dogs. This appears to have been well received and we look forward to it being completed in the not too distant future. There are many issues to be worked through so this could be quite a long process that will address many subjects including camping and ground maintenance.

The Benefit Shows were very successful and credit and thanks go to the organising committee for their hard work and commitment. Waikouaiti Kennel Association also ran a Forrester Park Benefit Show in association with their own shows and made a very good profit for maintenance at Forrester Park. Grateful thanks to WKA.

FPMC are very grateful to all their sponsors and in particular to our very generous major sponsors, Black Hawk and InterIslander, for the financial assistance provided for help in maintaining the property for the continued use of all DogsNZ members in the southern region. Without their valued support the work of the committee would be very difficult.

The committee continues to work well and does a very good job of managing the Forrester Park Black Hawk Event Centre. We have had one



member resign during the year and I would like to thank Lisa Terry for help and support over her time on committee. Lisa will be hard to replace. I would like to thank all the committee for their contributions over the past year. 🐾

## Wellington Management

### Key Financial Results:

The Black Hawk Wellington Exhibition Centre in Porirua achieved an operating Surplus of \$8,251, with a net result after depreciation of \$(23,894).

This was in-line with budget and the major change from previous year financials is the removal of interest received which now sits in the consolidated group accounts for Dogs NZ.

We remain reliant on two key income sources. Rental from non-member activity (\$37,392) and head office rental from Dogs NZ (\$45,000), which account for 61% of income.

Income from Club shows was down on previous year and budget but the facility is well supported by two benefit shows which generated income of \$11,310 and we remain grateful to the clubs and exhibitors who support these shows.

Without the naming rights sponsorship contribution by Master Pet "Black Hawk", our opportunity to post a positive operational surplus would be nil which shows the importance of renewing our existing sponsorship contracts on favourable terms.

Rates and Insurance remain our largest costs with steadily increasing insurance premiums due to earthquake risks of which we have little control over. Tight control on Repairs & Maintenance budget ensured that expenditure fell within 3% of budget.

### Club and Non-member utilisation of the facility:

It is pleasing to see that rental from non-member activity is growing. We offer a large covered space (which is in short supply) with car parking for public activity at a competitive rental.

We have a core of regular hirers of whom one (Porirua Indoor Sports) provides more income than all our dog shows. We have an increasing portfolio of casual hirers, which includes sports groups, car clubs, theatre groups and service groups like the annual Rotary Book Fair.

Dogs New Zealand member club's utilisation of the Exhibition Centre remains strong with regular dog training courses by the Wainuiomata and Titahi Bay dog training clubs and 16 shows by various local breed clubs.

The event highlight of the year was hosting the Black Hawk National Dog Show which due to the efforts of Peter Dunne and his event team was an outstanding success. A lot of work went into "dressing" the venue so that it provided a suitable welcoming environment for both exhibitors and the general public.



At present we have a facility that is “fit for purpose” for the type of dog shows and dog training activity that we have in the lower North Island. However it is a facility that is starting to show its age.

**Future Issues:**

It has been signalled in previous Yearly Reports that a positive financial surplus has been generated only by under investment in Repairs and Maintenance.

This is not a viable strategy and we have now approached the stage where we must have a considered long term plan to address the key structural issues of the roof and updating the kitchen – meeting room facilities. These projects will not be able to be funded from existing Wellington venue revenue streams and will require substantial investment from Dogs NZ financial reserves.

Whether Dogs NZ wants to allocate its existing financial reserves to facility upgrades is a question for future Executive Councils and we will be doing a considerable amount of work to provide a long term renovation plan which will outline the key financial implications for retaining the Porirua facility. The resident Wellington clubs will be involved in these planning discussions as the availability of a “fit for purpose” dog facility has a major impact on their show schedule.

We have taken the first steps in remedying the most urgent outstanding deferred maintenance issue with the replacement of a number of windows that are unlikely to survive another Wellington winter.

Behind any successful venue there is a hard working team. I would like to thank the Dogs NZ Head Office Finance Team, Graeme Sugden and Sue Barr who ensure that the venue bookings work smoothly and we remain financially viable.

Brian Kell (Caretaker) has the responsibility to ensure that the facility remains operational and we appreciate his “jack of all trades” skills and willingness to assist our venue hirers.

Once again we are grateful for the support of Gary Carleton and the team from the Hutt Valley Kennel Centre in organising benefit shows. The other benefit show was organised by a hard working group of volunteers led by Carolyn Stevens and Bill Crawford and we remain appreciative of their support. 🐾

# Remits

## Remit 1 by Executive Council

### Section III

#### 8A.2 Membership Fee scales

Add an additional rule 8A.2 (b) and renumber original paragraph A.2 (a)

8A.2 (b) Executive Council can at its discretion apply to the ACOD to increase the membership fee(s) by an amount above and beyond the CPI increase.

### Rationale

From time to time Executive Council may be required to seek additional income to maintain the functions of Dogs New Zealand. This remit will allow Executive Council, with the approval of the ACOD, to alter the membership fees by a nominated amount above and beyond any CPI increase.

In the face of declining membership (22% since 2012) and increasing demands on its resources Dogs New Zealand may from time to time require additional income. Over a sustained period of time there has been no other increase to the membership fees other than the CPI adjustments which has effectively restricted operating income in the face of increasing costs to include matters of compliance.



## Remit 2 by Executive Council

### Section III

8A.2 (a) Membership Fee scales

#### Current

Fees shall be adjusted on 1 July each year by the change in the Consumer Price Index as determined by Statistics New Zealand for the year to 31 March in the current year. All rates shall be rounded up to the next \$0.10. The Director/Secretary may amend this Rule to show the new rates each 1 July.

#### Proposed

Fees shall be adjusted on 1 July each year by the change in the Consumer Price Index as determined by Statistics New Zealand for the year to 31 March in the current year. All rates shall be rounded up to the next \$0.10. The Director Secretary shall calculate the proposed increases and they shall be presented at ACOD for ratification.

#### Rationale

This is a simple change in process to add more formality to it

## Remit 3 by Executive Council

### Section V

#### CONSTITUTION AND ELECTION OF OFFICERS

##### 20. CONSTITUTION (D) (VI)

#### Motion

That Rule 20 (D) (VI) be amended as follows to provide absolute clarity to the replacement process when an EC vacancy occurs.

Casual vacancies in the Executive Council shall be filled by the member who recorded the next highest number of votes, in the year of the election of the Executive Council member causing the vacancy, in each case, provided that he or she shall be prepared to serve on the Executive Council, but if there is no one so eligible, the casual vacancy shall in each case be filled by the Executive Council from amongst the appropriate North Island delegates, from the most recent ACOD, in case of a North Island vacancy, or from the appropriate South Island delegates in the case of a South Island vacancy. Any person so appointed to fill such a vacancy will be elected for the remainder of the term that has been vacated.

#### Rationale

With the change to the election cycle of Executive Councillors our Rules are not absolute regarding the replacement of EC members in the event of a vacancy occurring. This remit seeks to remove any potential ambiguity by ensuring that the replacement for a vacancy will always be found from the year of that members election and should there not be an eligible candidate then EC will make an appointment from delegates to the most recent years ACOD.



# Recommendations

## Recommendation 1 by Geraldine County Kennel Association Inc.

### Show Regulation 19.5

#### Professional Handlers

- 19.5.1 Save with the express permission of the Executive Council (which will be given in the most exceptional circumstances only) no person shall pay, or otherwise remunerate any other person for handling any dog in the judging ring at a Championship Show or Championship Obedience Test.
- 19.5.2 Any dog exhibited in contravention of this regulation will be liable to disqualification and any handler shall be subject to the disciplinary provisions of the rules of the New Zealand Kennel Club.

#### Motion

19.5, 19.51 and 19.52 Be removed from Regulations.

#### Rationale

The sport of showing dogs has declining numbers in New Zealand and places like Canada, USA, Australia and Europe show strong numbers and all have professional handlers. In addition New Zealand has an ageing group of breeders with great knowledge and the ability to continue breeding and exhibiting quality dogs. Many of these members struggle to find people to help show their dogs. It would be a shame if they stopped breeding and exhibiting. There are also many breeders/exhibitors unable to get away to show their dogs (too many responsibilities at home, job, shows too far away) and the help of a friend to take their dogs to shows and be able to be honest and contribute to pay someone for this will increase entry numbers. This would benefit the sport of dogs by more dogs being bred and entered in shows.

New Zealand has many young exhibitors that seem to go away, (university, work, families.) By allowing freedom for members to pay a handler of choice may allow some youth to stay involved and earn some income on weekends or cover their cost to get to a show. Currently handlers/exhibitors are being paid either through petrol money, accommodation costs and very possibly cash, so it would seem sensible to legitimise this rather than risk these handlers, owners and dogs being penalised.

There is no way that this country can ever evolve to the likes of Handlers in USA or Europe.

Judges are allowed to charge a fee to be in the ring and charge travel expenses to provide a service. Most of our Judges do not come on a work visa. There is no difference for a skilled Handler to be paid and present a dog to the best of its ability in the ring for a judge to examine.

## Recommendation 2 by Southland Kennel Association

### Show Regulations 19.11

#### 19.11 Neutered Dogs and Spayed Bitches

Neutered Dogs and Spayed Bitches may be exhibited in breed classes at any Specialist Breed, Multibreed or Group club Championship Show where the acceptance of entry from spayed and neutered dogs has been published in the schedule for the show.

Neutered Dogs and Spayed Bitches are disqualified from being shown in Breed Classes at all other Championship Shows.

A certificate of a veterinary inspector appointed by the show committee will be accepted as conclusive evidence in the event of a protest being lodged.

#### Recommendation:

19.11 Neutered Dogs and Spayed Bitches

19.11.1 Neutered Dogs and Spayed Bitches may be exhibited in breed classes at any Championship Show where the acceptance of entry from spayed and neutered dogs has been published in the schedule for the show. Neutered Dogs and Spayed Bitches will compete in their own classes (15, 16, 17 and 18) to be judged to Best and Reserve Neuter and Class for Breed and Group, and Best Neuter In Show and Class at In Show level.

19.11.2 Where only one Neuter / Spay class is offered in the schedule for the show, that class will be Open (18/18a).

#### Associated Regulations requiring changes

6.1.3 Add the following:

Class No 15 - Neuter Puppy Dog No 15a - Spayed Puppy Bitch (For neutered dogs or spayed bitches six and under twelve months of age on the first day of the show).

Class No 16 – Neutered Junior Dog No 16a – Spayed Junior Bitch (For neutered dogs or spayed bitches twelve and under twenty four months of age on the first day of the show).

Class No 17 – Neutered Intermediate Dog No 17a – Spayed Intermediate Bitch (For neutered dogs or spayed bitches twenty four and under thirty six months of age on the first day of the show).

Class No 18 – Neutered Open Dog No 18a – Spayed Open Bitch (For neutered dogs or spayed bitches six months of age and over on the first day of the show).



**7.5 to be re-written as:**

7.5 Neutered Dogs and Spayed Bitches at Championship Shows.

A Neutered Dog or Spayed Bitch can be exhibited

- In any stake class for which they are eligible at any Championship Show.
- In Breed Classes at any Championship Show where the acceptance of entry from spayed and neutered dogs has been published in the schedule for the show.

This clause shall allow the club holding the show to offer any or none of the Breed Classes for Neutered Dogs and Spayed Bitches.

**13 Judging Order**

Insert the following after 13.8, and renumber subsequent clauses 13.9 to 13.10 and 13.10 to 13.11

- 13.9. Neutered Dogs and Spayed Bitches will be judged at Breed level immediately after Best of Breed and any Class elimination judging  
Neutered Dogs and Spayed Bitches will be judged at Group and Show level immediately after General Classes.

**Registration Regulations**

Add to 5.1

- 5.1.12 Neutered Dogs and Spayed Bitches which are already recorded on the Part 1 Register, identified with the addition of the letter N at the end of the Registration Number.

13.10 Optional Ranking Procedure for Judging Group and In Show awards at All Breeds Shows Championship Shows

All Breeds Clubs may at their discretion adopt the following procedure for Group and In Show judging at Championship Shows.

The judging of Best of Group etc will be judged at the conclusion of judging in the following order: - Best of Group and Reserve Best of Group, followed by the Best of Group for all scheduled classes in ascending numerical order.

13.10.1 Best of Group placings are awarded from the Best of Breed winners. Best of Group and Reserve in Group awards are made followed by Baby Puppy of Group, Puppy of Group, Junior of Group, Intermediate of Group, N.Z. Bred of Group & Open of Group.

13.10.2 Best in Show is awarded from the Best of Group exhibits. Second to Fourth in Show awards can at the option of the Club be awarded. The second place in Group does not enter the ring for In Show judging. Best Puppy in Show is awarded from the Best Puppy of Group exhibits. Second to fourth Puppy in Show awards can at the option of the Club be awarded.

13.10.3 Clubs using this procedure must state in their schedule "Group and In Show judging will follow the ranking procedure for judging – Puppy of Group and In Show will/ will not be judged.

13.10.4 The Club may at its discretion award Puppy in Group and Puppy in Show awards. These are judged after the Group and In Show judging.

13.10.5 No other In Show awards are made.

### Rationale

The current Regulation allows for only Best of Group and Puppy of Group awards to be made. It is most unlikely that a Baby Puppy could win any award apart from Baby Puppy of Breed. Our Recommendation will include Group Awards for all class winners from Baby Puppy to Open.



## Recommendation 4 by Hutt Valley Kennel Centre

### 19.4 Dogs Owned, *co-owned* or Shown by Show Manager, Judges Stewards and Assembly Stewards

19.4.1 A Show Manager or a Judges Steward shall not *enter or* handle in any Show Ring any dog at any Championship Show at which they are officiating, provided always that this sub-paragraph shall not apply where an exhibitor acts in an emergency.

#### Rationale

The current Regulation reads:

19.4 Dogs Owned or Shown by Show Manager, Judges Stewards and Assembly Stewards

19.4.1 A Show Manager or a Judges Steward shall not handle in any Show Ring any dog at any Championship Show at which they are officiating, provided always that this sub-paragraph shall not apply where an exhibitor acts in an emergency.

By inserting “*co-owned*” after Dogs owned in 19.4 and “*enter or*” after shall not in 19.4.1 this tidies up this Regulation so that dogs co-owned by a Show Manager cannot enter any dog that is co-owned.



## Discussion Paper

### Exhibition of Neutered Dogs and Spayed Bitches at All Breeds Championship Shows

Over the last few years we have seen several discussion papers come to ACOD which have touched on the fact that we need to seriously look at making some changes for the future. If we really want to encourage new exhibitors into the ring, bring back previous exhibitors who have left or even keep those who we already have then we need to start taking action and making some of these changes that we talk about.

One of the points often raised but never implemented relates to the exhibition of spayed bitches and neutered dogs at All Breeds Championship shows.

This is an item that has been previously brought to the table on more than one occasion and for various reasons never made it across the finish line.

Currently we allow for these dogs to be exhibited at championship level for Multi Breed, Breed Specialty and Group Specialty shows, however, we still exclude them from our All Breeds Championship shows.

Recently there have been a few instances where this topic has been raised on Social Media and it has provided the opportunity for those Social Media savvy members to give their thoughts and feelings on the topic.

Whilst there has been a large variation in the responses around how people think this should be applied, there has still been a consistent message coming through. That message has been that this is a change that is needed in some shape or form.

Many of those people making comments on this topic have made reference to the number of reasons that a dog or bitch could have been desexed. Reasons such as the following have been mentioned;

- \* A Result of medical complication such as Pyometra or Testicular Cancer.
- \* To prevent medical conditions mentioned above.
- \* Puppy sold as pet and then the new owner decides to give showing a try.
- \* Council registration is often significantly cheaper for desexed dogs.
- \* Convenience for the owner!!

With the best interests of DogsNZ at the front of our minds, Franklin Kennel Association would like to bring this issue forward to ACOD in 2020 with the hope of having this change finalised.

The intention of our Discussion Paper this year is to get a comprehensive understanding and open discussion happening around how you would like to see this change made.

  - \* Would you like to see desexed dogs exhibited in their own independent classes referred to as the 'Spayed Bitch' class and 'Neutered Dog' class? Again, these dogs would then still be eligible to compete for the CC, Best of Breed and any relevant Group or In Show awards.
  - \* Would you like to see Dogs NZ follow Australia's lead with a completely separate title for desexed exhibits which would not see them compete against entire dogs at all?

These are just some of the suggestions that have been made to date and we welcome your discussion and thoughts on the topic.



## **New Zealand Kennel Club Incorporated**

### **Entity Information**

The New Zealand Kennel Club was established in 1886. It exists primarily as an organisation of dog owners which gives it collective bargaining power and a single voice to Government, the general public and other interest groups on behalf of dog breeders, dog owners, Kennel Clubs and other associated societies in the canine world.

It maintains a database which traces the genealogy and pedigree of New Zealand Dogs as well as progression of sports and activities associated with Canines. (Breed Clubs, Obedience, Agility, Working Trials, Canine Good Citizen™, New Zealand Young Kennel Club and others).

The New Zealand Kennel Club is an organisation that operates at two levels.

- **Affiliated Societies**

From its inception in 1886, the New Zealand Kennel Club was an association of societies and still is today. There are 284 societies affiliated to, associated with and recognised by NZKC. All New Zealand Kennel Club member societies are required to have written constitutions.

As a member of the New Zealand Kennel Club a society is restricted to act only as permitted by the New Zealand Kennel Club Rules and Regulations and the club's status pursuant to those rules and regulations. It is restricted to do those things only permitted by its constitution and the laws of the country.

- **Individual Membership**

Individual membership allows a member, among other things, to register a dog with NZKC, enter a dog in a show or competition, be a delegate to the Annual Conference, and hold executive office in any Affiliated or Associated Society

### **Governance**

NZKC holds an annual conference of delegates. This gathering, attended by delegates from throughout the country elects a governing council to run the affairs of the body. It gives policy direction for the following year, approves accounts and sets membership fees.

### **The Executive Council**

The Executive Council meets six times a year to consider business. The day to day running of the Society is delegated to the administrative staff, headed by the Directory Secretary. Administration deals mainly with the finance, register, membership matters, the NZ Dog World and the website.

### **Funding**

Funding is provided primarily from individual membership subscriptions, fees for registration of dogs, sponsorship and levies from club shows.



## Independent Auditor's Report

### To the Executive Council of New Zealand Kennel Club Incorporated

#### Opinion

We have audited the financial information in the accompanying financial statements of New Zealand Kennel Club Incorporated (the 'Club'), which comprises the statement of financial position as at 31 March 2019, and the statement of financial performance, the statement of movements in equity and statement of cash flows for the year then ended, and the statement of accounting policies and other explanatory information in notes 1 to 14.

In our opinion, the financial information in the financial statements presents fairly, in all material respects, the financial position of the Club as at 31 March 2019 and its financial performance and cash flows for the year then ended in accordance with Public Benefit Entity Simple Format Reporting – Accrual (Not-for-Profit) issued by the New Zealand Accounting Standards Board ('PBE SFR – A (NFP)').

#### Basis for opinion

We conducted our audit of the statement of financial performance, statement of financial position, statement of cash flows, statement of accounting policies and notes to the financial information in the financial statements in accordance with International Standards on Auditing ('ISAs') and International Standards on Auditing (New Zealand) ('ISAs (NZ)'). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

We are independent of the Club in accordance with Professional and Ethical Standard 1 (Revised) *Code of Ethics for Assurance Practitioners* issued by the New Zealand Auditing and Assurance Standards Board and the International Ethics Standards Board for Accountants' *Code of Ethics for Professional Accountants*, and we have fulfilled our other ethical responsibilities in accordance with these requirements.

#### Other information

The Executive Council is responsible on behalf of the Club for the other information. The other information comprises the entity information on page 3 and the statement of service performance on page 17 that accompanies the financial information included in the financial statements and the audit report.

Our opinion on the financial statements does not cover the other information and we do not express any form of assurance conclusion thereon.

Our responsibility is to read the other information, and consider whether it is materially inconsistent with the financial statements or our knowledge obtained in the audit or otherwise appears to be materially misstated. If so, we are required to report that fact. We have nothing to report in this regard.

#### Executive Council's responsibilities for the financial statements

The Executive Council is responsible on behalf of the Club for:

- the preparation and fair presentation of the financial statements on behalf of the Club in accordance with PBE SFR – A (NFP), and
- for such internal control as the Executive Council determine is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, the Executive Council is responsible on behalf of the Club for assessing the Club's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless the Executive Council either intends to liquidate the Club or to cease operations, or has no realistic alternative but to do so.

**Auditor's responsibilities for the audit of the financial statements**

Our objectives are to obtain reasonable assurance about whether the financial information in the financial statements as a whole is free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with ISAs and ISAs (NZ) will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of the financial statements.

As part of an audit in accordance with ISAs and ISAs (NZ), we exercise professional judgement and maintain professional scepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the financial information in the financial statements, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Club's internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by the Executive Council.
- Conclude on the appropriateness of the use of the going concern basis of accounting by the Executive Council and, based on the audit evidence obtained, whether a material uncertainty exists related to events or conditions that may cast significant doubt on the Club's ability to continue as a going concern. If we conclude that a material uncertainty exists, we are required to draw attention in our auditor's report to the related disclosures in the financial statements or, if such disclosures are inadequate, to modify our opinion. **1. STATEMENT OF ACCOUNTING POLICIES**

**Reporting Entity**

New Zealand Kennel Club Incorporated (the "Club") is a society incorporated under the Incorporated Societies Act 1908, and trading as Dogs New Zealand. These financial statements are for the group which comprises the Club, the New Zealand Kennel Gazette Limited registered under the Companies Act 1993, a wholly owned subsidiary of the Club and the New Zealand Kennel Club Museum Trust Incorporated (the "Museum Trust"), which the Club has control over.

**General Accounting Policies**

These financial statements are reported under Tier 3 of the PBE SFR (accruals for NFP) as expenditure is less than \$2 million per annum.

**Measurement Base**

The accounting principles recognised as appropriate for the measurement and reporting of earnings and financial position on a historic basis are followed by the Club.

**Specific Accounting Policies**

The following specific accounting policies which materially affect the measurement of financial performance and financial position have been applied:

**(a) Goods and Services Tax ("GST")**

These financial statements have been prepared on a GST exclusive basis, except for accounts receivable and accounts payable, which are reported on a GST inclusive basis.

**(b) Property, Plant and Equipment**

Property, plant and equipment is recorded at historical cost, less depreciation and impairment.

**(c) Depreciation**

Depreciation has been calculated on a straight line basis at the following rates:

Buildings	2.50%
Freehold Improvements	10.00%
New Freehold Improvements	5.00% to 10.00%
Computer Equipment and Software	25.00%
Tractor and Equipment	15.00%
Office Furniture, Equipment and Tools	10.00% to 20.00%

**(d) Taxation**

The Club is recognised as being a sporting body and as such is not liable for income tax under CW46 of the Income Tax Act 2007. The Club has a tax exemption certificate from Inland Revenue.

**(e) Principles of Consolidation**

(i) These financial statements are for the group which comprise the Club, its wholly owned subsidiary the New Zealand Kennel Gazette Limited and the Museum Trust. The New Zealand Kennel Club Gazette Limited as a company does not trade and all activities associated with the Gazette are treated as a business unit of the Club. The Museum Trust has a term deposit as shown on Note 4, the interest of which is immaterial to the results of the group. As the subsidiaries are either non-trading or are immaterial to the group, the results of the parent have not been shown separately. The balance date of both subsidiaries is 31 March.

(ii) The Statement of Financial Performance on page 4 eliminates all intra group transactions.

**(f) Receivables**

Debtors are stated at estimated realisable value.

**(g) Income Recognition**

Subscriptions and memberships are accounted for over the period of the membership with future income recorded as deferred revenue. Other income including Affiliation Fees are accounted for on an accruals basis. Those Affiliation Fees received that are related to the next financial year are recorded as receipts in advance. Revenue from gate sales and fund raising activities is recognised as earned, as their receipt cannot be anticipated. There is no income outstanding at year end that was received on a use or return basis.

**(h) Donations**

Donations and other gratuities are recognised as revenue at the point when receipt is formally and officially acknowledged by the Club.

**(i) Income Reclassification**

Sponsorship Income totalling \$23,068 in 2018, previously reported as National Dog Show, Property and Activities income has been reclassified into sponsorship.

**(j) Changes in Accounting Policies**

There were no changes in accounting policies as a result of changing from reporting under GAAP to reporting under Tier 3.

**(k) Operating Leases**

Leases that do not transfer substantially all the risks and rewards incidental to ownership of an asset the entity are classified as operating leases. Lease payments under an operating lease are recognised as an expense on a straight line basis over the term of the lease in the statement of financial performance.

## FAQ...

### **What were the main factors that contributed to the cash surplus of \$148,273, against a budgeted surplus of \$105k?**

1. Registry income, particularly dog transfers was a major contributor. The introduction of a CH&W levy, which was not budgeted was also a factor.
2. The Gazette had improved revenue, and there were savings in personnel due to a vacancy, and in printing costs.
3. National Dog Show revenue and expenses were both favourable to budget.
4. Dog Agility Championship budgeted for a small deficit, but made a surplus of \$10k
5. Dunedin had favourable revenue and expenses against budget.

### **Did any areas impact negatively to the result.**

In order to improve safety Agility were required to upgrade equipment at a cost of \$14k. A GIP seminar was also held which was not in the original budget.

### **What contributed to the success of the National Dog Show?**

Using our own premises in Wellington is a big plus, as venue costs can be kept to a minimum. The best comparison is against the show held in 2015 where a similar surplus resulted. There was minimal grant revenue for the 2018 event, that being the main variance to the 2015 event. Savings were made by not having a marquee to provide extra grooming space, and there was less marketing, although gate receipts were still on a par with the 2015 event.

### **Is there a reason the National Dog Obedience Assembly consistently records a loss each year?**

Similar to the National Dog Show and the New Zealand Dog Agility Championships the National Dog Obedience Assembly is held in a different part of the country each year. The deficit for this year was an improvement on the 2017 event but the result remains a ongoing issue.

### **What investment has been made in the properties NZKC own?**

There was minimal investment in any of the three venues. This is set to change in the 2019-20 year with substantial amounts budgeted for each of the three properties that Dogs NZ owns. The largest investment is budgeted for Auckland with upgrading of the grounds required in order to attract an increased utilisation. and for the 2020 National Dog Show which will be taking place on our own premises rather than using the Vector Arena which due to the cost of hiring does mean it is almost impossible to return a surplus on that event. The implement shed needs replacing, and this is likely to be a major cost. In Wellington a number of the windows need to be replaced as they are in a very bad state of repair. In Dunedin the egress is being upgraded to conform to health and safety requirements.

## **Are there any areas of revenue that need to be highlighted?**

Membership is flat (5,079 v's 5162). Whereas new members were close to 600 in the year, we are clearly not retaining our existing members, with close to 700 not renewing. Included in the 2019-20 Business plan are programmes designed to address both these issues. Registry revenue for the year was \$484k v's a budget of \$458k, and \$431k last year, a very positive result. An increased membership should have a flow on effect to this area of revenue as well. Apart from activities the other area of revenue is from our three properties, with the potential in Auckland of an increase subject to consent changes and upgrade work that is planned.

## **Are there any areas of expense that need to be highlighted?**

**Agility** spend was a major variance as already noted.

**Personnel** costs are the single largest item of expenditure at \$640. This was below budget, (\$660k), but only due to vacancies which had not been filled at year end. In comparison last year was \$656k.

**Administration Costs.** Legal costs were still an issue due to ongoing litigation, with a spend of \$43k v's a budget of \$12k. Over the past 3 years litigation has cost in excess of \$100k, with minimal likelihood of any recovery.
